What do we process your data for? Your data will be processed for the management and supervision of our staff selection procedures.

How did we obtain your data? We have been provided with your Curriculum Vitae, either directly by you yourself, or by the employment website through which you applied to take part in our selection procedures.

**How long will we keep your data?** We will keep your CV for up to one year from the date of its latest update, so that you will have to submit a new up-to-date CV if you wish to continue to take part in our selection procedures.
